We wish to inform the Commission of the hiring of Ms. Juanita Margarita O. Umali as the Head of the Credit Card Group with the rank of Senior Vice President effective July 21, 2014.

Ms. Umali has no beneficial ownership over any shares of PNB as of this date.

We trust you will take note accordingly.

This number includes the 423,962,500 common shares (the "Shares) deemed issued to the stockholders of Allied Banking Corporation (ABC) relative to the merger of PNB and ABC as approved by the Securities and Exchange Commission (SEC) on January 17, 2013. The shares are the subject of the Registration Statement filed with SEC and for listing with the Philippine Stock Exchange. This also includes a portion of its Stock Rights Offering (Offer) of 162,931,262 common shares (Rights Shares), particularly 33,218,348 Right Shares, which was sourced from the existing authorized but unissued capital stock. The remaining 129,712,914 Rights Shares subject of the Offer will be sourced from an increase in authorized capital stock of the Bank and have therefore not yet been issued.
